BrahMos deal with Vietnam signed; Indonesia pact in final stages: India

Singapore: Defence Secretary Rajesh Kumar Singh said on Saturday Vietnam has signed a deal with India for the BrahMos missile system, while a similar agreement with Indonesia is in its final stages. Speaking at the Shangri-La Dialogue in Singapore, Singh said he understood the Vietnam deal had been signed but had not yet been publicly announced. He added negotiations with Indonesia were nearing completion.

The Philippines became the first foreign buyer of the BrahMos missile system after signing a contract worth nearly \$375 million in 2022. Indonesia announced in March that it had reached a deal with India to procure the missile system. While media reports earlier this month suggested Vietnam was close to finalising an agreement, Singh's remarks are the first official confirmation in the public domain. The value of the Vietnam and Indonesia deals has not been disclosed.

On sharing advanced de-

fence technologies, Singh said sophisticated weapons systems were generally supplied to trusted partners. India, he said, remained committed to the Association of Southeast Asian Nations and viewed its

member states as friendly nations with whom it could share advanced defence technologies. He stressed on the need for resilient and diversified defence supply chains, saying India was expanding defence production, encouraging private-sector participation and emerging as a dependable defence manufacturing hub.

Hegseth warns of rightful alarm over Chinese military build-up

SINGAPORE

There is "rightful alarm" in the Pacific over China's military build-up and the US seeks a regional balance where no state has unchecked power, Pentagon chief Pete Hegseth said on Saturday. "When we look across the region today, there is rightful alarm regarding China's historic military build-up and the expansion of its military activities in the region and beyond," Hegseth told

Asia's defence summit in Singapore. He added Washington did not seek "needless confrontation in the region".

Hegseth spoke at the Shangri-La Dialogue, which brings together top defence officials and experts from around 45 countries.

In his speech, Hegseth said Washington sought "a genuinely stable equilibrium in Asia that works for Americans as well as our allies".

That means "a favourable

but durable balance of power in which no state, including China, can impose its hegemony and hold the security or prosperity of our nation and our allies in question", he said.

Hegseth's remarks follow a Reuters report that Beijing is building a sprawling web of

launch pads, bunkers and communications nodes near isolated nuclear silos that hold the Chinese military's longest-range missiles.

China's nuclear build-up is among the most scrutinised facets of President Xi Jinping's military modernisation beca-

विधायक ने छावनी परिषद सीईओ को लिखा पत्र

-कहा कि अवैध स्लाटर हाउस तत्काल बंद कराया जाए
-बजरंग दल ने प्रदर्शन कर सौंपा ज्ञापन
-प्रशासन ने कहा कड़ी कार्रवाई करेंगे

महू। बंडा बस्ती में शुक्रवार को गोवंश की आशंका पर हुए हंगामे के बाद मामला अब सियासी और सामाजिक दोनों स्तरों पर गरमा गया है। बजरंग दल कार्यकर्ताओं के अनुसार इमरान उर्फ खटखट के बाड़े से मांस और अवशेष बरामद होने की बात पर हंगामा हुआ। इसी दौरान दूसरे पक्ष से पथराव शुरू हो गया। मौके पर पहुंची पुलिस ने स्थिति नियंत्रित की। अब क्षेत्र में सामान्य स्थिति बताई जा रही है। पुलिस गोवंश
